The last effort he worked at Hanscom was the Three-Dimensional Expeditionary Long Range Radar (3DELRR), a major defense acquisition program. Upon RFP release he was off to Air Command and Staff College where he received his third Master's in Military Operational Art & Science. From there he went to the Air Force Nuclear Weapons Center (AFNWC) at Kirtland AFB, NM where he worked a number of Advisory & Assistance Services (A&AS) and Systems efforts. In 2016, after a little over 21 years of Air Force acquisition, he became the Contracting Resource Manager and Subject Matter Expert for the Directorate, as well as the Director of Small Business Programs. In 2019, he was made the Center Small Business Director full-time. His duties also included work as the AFNWC Services Acquisition Lead supporting the Deputy Program Executive Officer (PEO) for Strategic Systems, the Center Executive Director, and the Commander. He worked in that position until moving to the Pentagon.
