US Congress in Hot Debate Over TPA (Trade Promotion Authority)

USPAACC National President & CEO Susan Au Allen discusses with Asian American Members of Congress in April and raised the subject matter of TPA with Representatives Mike Honda (D-CA), Judy Chu (D-CA) and Mark Takano (D-CA).

TPA is also known as "fast track" trade legislation. It allows the White House to negotiate trade agreements which it submits to Congress for straight up-or-down votes within 90 days and with no amendments. The Bush administration used it to negotiate trade agreements with 16 countries in Latin America, the Middle East and the Asia-Pacific region before the "fast track" authority expired in June 2007. "Fast track" was used to encourage other countries to put their best offers on the table; however, it is unpopular with labor groups who believe it will encourage U.S. companies to move jobs overseas. President Obama has not sought to renew the legislation in the past but he wants it now. Even without the fast track authority, the Obama administration has been pursuing a free trade agreement known as Trans-Pacific Partnership (TPP) with at least ten countries in the Asia-Pacific region. These negotiations date back to the last years of the Bush administration.

President Obama wants TPA, most of the Republicans in Congress want it, but there are strong skeptics among the Democrats. Supporters believe they will help to preserve American competitiveness and continue to enable the United States to play a leadership role in global economics that is linked to other geopolitical considerations. Opponents worry that TPA is not transparent, and will further erode American jobs. USPAACC is polling its members for their comments and opinions. Early signs show support for passage of TPA after which discussions on the second phase, TPP, will begin.

USPAACC has a 26-year history of ensuring a bright future for our children by investing in our country's future leaders. Since 1989, starting with one scholarship and through the generosity of Asian American and corporate sponsors, and under the aegis of USPAACC, over \$1 million in scholarship and fellowship benefits have been awarded to outstanding American high school seniors heading toward college.

Through the years, Asian American businesses have endowed students with their eponymous scholarships, and major corporations have established their hallmark scholarships with USPAACC.

Today, over 3,000 applications are received each year and approximately 15 to 20 scholarships are awarded annually to students nationwide for post-secondary education. These recipients have demonstrated academic excellence, community service and leadership, and financial need.
